Legal and Compliance

Report

The Head of Legal and Compliance then showed a video extract of **Dispatches: Undercover Copper**. She gave the Board a summary of the processes which have been put in place to get this programme on screen and explained that the Channel has followed absolute best practice. There then followed an informative Board discussion around this programme and the procedures adopted.

In response to a query by Sue Ashtiany, the Head of Legal and Compliance explained that we have to comply with OFCOM rules and codes and also with applicable legislation. The Channel cannot cater for every eventuality, but we have our own internal rules in place to ensure compliance. These tend to be bespoke for each production, but the Head of Legal and Compliance is currently working on pulling these together into one internal document which should be ready within the next few months. It was agreed that this code would be brought to the Board once prepared.

Audience Research – C4 Paper 703 (14/06)

The Controller of Research & Insight joined the meeting and gave a presentation of some qualitative research which has recently been carried out in respect of Channel 4.
